





The Herrin Coal is a normal brightbanded coal. Its lower portion contains a prominent claystone parting (the "blue band") that normally is 1-3 inches thick. It averages more than 6 feet thick in extensive areas and locally reaches 15 feet. It is thin in much of central Illinois but has been extensively mined in western, west-central, southern, and northern Illinois, as well as in the southern part of the Danville region of
